Priority #2

Protect Fuel and Technology Choice

Contractors call upon decades of experience and industry standards to help consumers balance comfort, safety, efficiency, and affordability in designing comfort systems for their homes and businesses. But regulators increasingly limit consumer choice with bans on natural gas or specific technologies like noncondensing furnaces.


Promote Energy Efficiency Through Quality Installation

Efficiency incentives should reward quality installation, not just equipment ratings. Fortunately, smart connected tools and third-party verification like ACCA's Quality Installation (QI) certificates now allow policymakers to incentivize realized efficiency like never before.

A second chance for efficiency tax incentives?

We agree efficiency tax incentives could be improved and more affordable, but the One Big Beautiful Bill left no room for nuance – 25C, 179D, 45L, and 25D were eliminated entirely. Dozens of House Republicans signed letters supporting these credits and they could be restored at a lower cost by eliminating prevailing wage bonuses and adding quality installation requirements.

Minimize Disruption from Refrigerant Transitions

Even as contractors help their customers navigate a costly transition from HFC refrigerants to mildly flammable A2L refrigerants, some states are already pushing another transition to highly flammable A3 refrigerants as soon as 2034. Congress should act to prevent a chaotic and costly patchwork of state refrigerant regulations.





New York State's Part 494 regulation effectively mandates a transition to highly flammable propane by 2034. *Our industry is nowhere near ready.*

Fulfilling the promise of the AIM Act

The AIM Act of 2020 was enacted with bipartisan support because it promised an orderly, national phase down of HFCs, but it failed to prevent California, Washington, New York, and others from moving towards a patchwork of accelerated phase-outs, reclaim mandates, and certification requirements.

How Congress can help: Add federal preemption to the AIM Act

Congress should avert a dangerous rush to highly flammable A3 refrigerants and uphold the original promise of the AIM Act by amending it to preempt state refrigerant regulations.
